## **ADDITIONAL TRAINING**

**Virtual Life Design Studio Training, Stanford Life Design Lab, June 4, 2026 – June 10, 2026.** The Studio was an intensive 40-hour active design process workshop for university educators to engage in collaborative synchronous learning through assessments, design challenges, and highly interactive discussions in breakouts and plenary sessions. The online Studio introduced me to the global cohort of life design educators and facilitated development of collaborative relationships to support life design work. During the first two days of the workshop, I experienced life design curriculum firsthand as a learner. On Day 3, I engaged deeply with the pedagogy and materials to begin the process of designing a curriculum prototype. On Day 4, I continued building the prototype with the support of coaches and feedback from peers. On the final day, I used the mindset of bias towards action to build, envision, prototype, and tell the story of what life design at my university could look and feel like.

**Online Teaching Training, Tulane University’s Center for Engaged Learning and Teaching and Innovative Learning Center, May 26, 2020 – June 26, 2020.** This workshop consisted of five modules designed to provide faculty with the fundamentals of course design as they apply to online pedagogy. At the conclusion of the training, I was able to: (a) Identify principles and best practices of online pedagogy; (b) Create an online course aligning course objectives, learning outcomes, content delivery, learning activities, and assessments in an easy-to-navigate experience for students; and (c) Utilize a variety of technologies to facilitate delivery of the online course and achievement of course learning outcomes.
